- **Unfinished Business:**
 1. Ord. 2015-30: An Ordinance to amend the Zoning Plan and Map of the City of Grandview Heights by changing the zoning classification of the property located at 1192 Grandview Avenue from Limited Commercial (C-1) to Residential Single District (RS-2). *Pending Third Reading.*
 2. Ord. 2015-35: An Ordinance to make supplemental appropriations for expenses of the City during the fiscal year ending December 31, 2015, and declaring it an emergency. *Pending Second Reading* (Assigned to Finance Committee)
 3. Res. 16-2015: A Resolution Accepting the Recommendations of the Grandview Heights Tax Incentive Review Council of Various City of Grandview Heights Tax Incentives. *Pending Third Reading.* Assigned to Economic Development Committee.

 4. Mayoral objection: Ord. 2015-28: An Ordinance to prohibit the selling to and consumption of cigarettes and other tobacco-related products by persons under 21 years of age within the City of Grandview Heights, Ohio.

ORC 705.75: ... When the mayor refuses to sign any ordinance or resolution, or part thereof, and returns it to the council with his objections, the council shall, after the expiration of not less than one week, proceed to reconsider it, and if, upon reconsideration, the resolution or ordinance, or part or item thereof, disapproved by the mayor is approved by the vote of two thirds of all the members elected to the council, it shall then take effect as if it had received the signature of the mayor.
